

**1) Linda Andrews:** 588-8446

57204 N Sunset Rd, Benton City

From the 240 Bypass, drive west on Van Giesen through West Richland. From the west side of West Richland, drive 4.6 miles to Sunset Rd. Turn right and drive 2.3 miles on Sunset Rd. Studio is signed and on the left. Or, take I-82 to Benton City (exit #96), then Highway 224 east to Sunset Road and turn north (left). (In the middle of the Red Mountain wineries.)

**2) Jan Nilsson:** 967-3663

1528 Riverside Dr, West Richland

Take Van Giesen to West Richland. After crossing the Yakima River, turn left at Brick House Pizza onto 38<sup>th</sup>. Drive about ¼ mile and turn left on Broadview Ave. Drive another ¼ mile and merge with Riverside Dr. Continue 4 houses on Riverside Dr to 1528 on the left. Mail box is labeled "MARTIN 1528".

Richland Airport

Go north on 240 Bypass, past Van Giesen, turn left on Airport Way. Road veers left and becomes Terminal Drive. Proceed to the hangar located just to the right of the Richland Airport Tower. (Hangar does not have a visible street number. Follow the signs.)

2119 Newcomer, Richland

Drive north on George Washington Way to Saint St, turn left (west), go about 0.4 miles to Newcomer Ave, turn left. Go 0.2 miles, Studio-K is on the right.

**5) Chris Walling:** 521-9970

631 Lynnwood Lp, Richland

Drive north on George Washington Way to Saint St, turn left (west) and go 2 blocks to Lynnwood Loop then turn right. Studio is located on the left.

**6) April Ottey:** 554-0148

65 Park St, Richland

From the 240 Bypass, turn east on Van Giesen; left on George Washington Way; right on McMurray; left on Davison Ave. Go 2 blocks and take a right on Park St. Second house on the right.

**7) Consuelo Soto Murphy:** 727-7770

1509 Sanford, Richland

From the 240 Bypass, go east on Van Giesen; turn right on Sanford Ave; go two blocks.

**8) Philip Harding:** 420-4644

361 Sanford, Richland

From the 240 Bypass turn east on Duportail St. until you reach Sanford Ave. The house is on your right on the SW corner of Duportail and Sanford.

**9) Suzy Vitulli:** 628-6656

1513 Adair Court, Richland

From the 240 Bypass, merge to the right onto Columbia Park Trail. Drive 1.1 miles and turn left on Leslie Road. Take first right on Canyon, then first left on Oxford. Oxford turns into Adair in .3 miles, at the top of the hill. Adair Court is first left after it turns into Adair.

**10) Katherine Sylvan:** 221-1592

802 S. Kellogg St, Kennewick

From Clearwater, drive South on Kellogg for .7 mile to 8<sup>th</sup>, where you will turn right (west) and park on 8<sup>th</sup>. Our brick house is on the SW corner of 8<sup>th</sup> and Kellogg. Follow signs and enter through garage to studio.

**11) Kasia Gorski Schmoll:** 948-3812

Drive east on HWY 240, take the 395 S exit, keep left at the fork and exit the roundabout on Columbia Dr. Take a slight right onto N Benton St, then a right onto W. 1<sup>st</sup> Ave, gallery on the right.
